COVID MANDATES

By entering these dog trials, you are acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present. We will email all pre-entered persons, two weeks prior to the earthdog and trailing/locating tests, current information regarding all Covid mandates regarding masks, etc. We will also post this information on our website and on our facebook page.

If we have to cancel our tests because of Covid we will give 100% refunds. All checks will be held until the tests are completed.

Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one time fee of \$10.00. You may register your dog online at <http://nasda.dog/registration/>.

Awards:

Awards are self-service. Flat ribbons are offered for Qualifying, Best of Breed and High in Trial.

Notice to Exhibitors:

- This event is open to all dogs 6 months of age and older.
- Withdrawal of entry before the closing date will receive a refund less a \$5 processing fee per entry.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when in the ring.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Border Terrier Club of the Redwoods reserves the right to refuse any entry without cause or explanation.
- **Trial begins at 3:00 PM on Friday and at 9:00 AM on Saturday and Sunday. The second test each day will start at the conclusion of the first test after a short break.**
