This is a fun test offering nose work experience for interested nosework teams. While this Sniff & Go will be generally following National Association of Canine Scent Work (NACSW™) procedures, it is not a sanctioned event. There will be no ribbons or awards. Completion does not lead to a title.

### TESTS OFFERED

Levels 1 & 2 tests will be offered, with Interior, Exterior, Vehicle, and Container hides. Level 1 will be offered in the morning.. Level 2 will begin at the conclusion of Level 1 trials.

### Entry Limits / Running Order

Thirty Six (36) dogs will be entered for each day, with no more than sixteen (16) in Level 2. Individuals who commit to volunteering will be guaranteed a test. Individuals volunteering to assist Earthdog will be given a priority. With those priorities in mind, entries will be accepted and running order will be established in the order that entries were received. A waiting list will be maintained.

You need just one entry form for each dog.

### Schedule

CHECK IN with Test Secretary, even if you have pre-entered. Level 1 test will begin at 8:00 AM. Level 2 will begin immediately after Level 1. The judges, at their discretion, will take a 1 hr lunch break.

### Entry Fees:
