

### NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The BTCR and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The BTCR reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the BTCR or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

This club does not agree to arbitrate as stated on the AKC entry form.

### REFUNDS

No refunds will be given for overpayments of \$6.00 or under.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, weather or any other cause beyond the control of the organizing committee.

No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

If an entry was made online, no refund of the service fee will be refunded for any reason.

Refunds for injured dogs or handlers: 50% refunds will be given for a dog or handler that has a note from their veterinarian or doctor saying they cannot participate in the show. The doctor's appointment must have been before the show.

Full Entry fees will be refunded if an entry is pulled before the closing date/ time.

However, online convenience fees will not be refunded.

Bitches in season are not permitted to compete in Agility Trials. Bitches in season are not allowed on the show grounds. As such, the club will issue full refund minus \$5.00 processing fee for bitches unable to compete for this reason if the Trial Secretary receives WRITTEN notice of withdrawal no later than 30 minutes prior to the start of the first class.

Change of judge: If the judging assignment changes after the distribution of the premium list, an exhibitor has the right to request a full refund of their entry fees for any class affected. Exhibitors must submit requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day the exhibitor is entered.

### WAITLIST

BTCR IS OFFERING A WAIT LIST to fill openings made by withdrawn entries after the trial's official close.

Only paper entries can be waitlisted. Online entries are not eligible for wait listing. All entries, including wait listed entries, must be received by the Trial Secretary by 11:59 p.m. on the trial's closing date. A maximum of fifty (50) runs will be placed on the club's wait list. Any entry that is withdrawn by 6 p.m. on Monday, October 30, 2017, will be replaced by a waitlisted entry IF any of the fifty (50) runs are available. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. Any waitlisted entry that does not move off the wait list into the trial by Monday, October 30, 2017, at 6 p.m. will receive a full refund.

### RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

### VENDORS

Vendors must contact the trial chair, Mary Powell, before coming to the trial. Per Fairgrounds policy the charge is \$65.00 per weekend whether a vendor is there one day, two or three for a 10X20 set-up area. You may contact Mary Powell at [mary@lotsadogs.org](mailto:mary@lotsadogs.org)

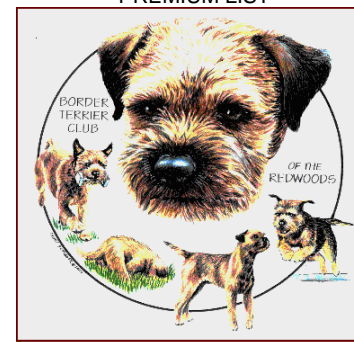

**MEASURING & JUMP HEIGHT CARD INFORMATION**

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid 329 jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during the day of show check-in. However, it is the sole responsibility of the exhibitor to have their original, official jump height card or temporary jump height form at each trial to present upon request. Additionally, if a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. **Regulations for Agility Trials, Chapter 2, Section 4.**

**MOVE-UPS**

**All pre-show move ups** must be received by 6pm, Monday, October 30, 2017. The AKC requires move-ups to be in writing. You may send an email for a move-up to [agilityentry@mycci.net](mailto:agilityentry@mycci.net) with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days, even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

**There will be day-to-day move-ups at the show**, provided the Trial Secretary receives them within **15 minutes after the end of the last class**. There will be no move-ups in the morning before the start of the trial. EXCEPTION: A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class. **Move Down:** After the close of entries a dog may be moved down in its class level (i.e. Master to Excellent). The request must be in writing and submitted to the trial secretary at least 30 minutes prior to the start of the trial.

**RIBBONS, AWARDS, AND PRIZES**

Rosettes will be awarded in each jump height division in each class as follows:

*First Place – Blue, Second Place – Red, Third Place – Yellow, Fourth Place – White*

A New Title rosette will be awarded to all dog and handler teams finishing a title, while quantities are available. A MACH rosette will be awarded to all dog and handler teams that attain their MACH. A PACH rosette will be awarded to all dog and handler teams that attain their PACH. A flat green ribbon will be awarded to all dogs that earn a qualifying score. A QQ pin will awarded to all Excellent B dog and handler teams qualifying in both Master STD and Master JWW on the same day, while quantities are available (with Master FAST or T2B=QQQ.) A Rosette for "High Scoring Border Terrier" in Novice, Open and Ex/Master will be awarded at the end of the trial based on most Q's and least number of faults. A tie will be decided by considering yards per second.. T2B ribbons will be awarded dogs that earn 10-8 pts. T2B pins will be awarded to dogs earning their T2B title, while supplies last. **All prizes, awards and ribbons must be picked up before the end of the show. No ribbons, etc., will be mailed after the show.**

**VOLUNTEERS**

It is difficult to run a trial without help. Volunteers will receive a \$2.00 voucher for each class worked and a \$4.00 voucher for the last class of the day. Vouchers are good for the BTCR Jan 2017 agility trial and are non-transferable. On the day of the trial, white boards will be placed at each ring to sign up to work. **DIRECTIONS TO THE TRIAL SITE**

**From the South via US 101** Take 101 north to Santa Rosa. Exit onto Highway 12 exit towards Sonoma (east); **stay in the right-hand lane**. From Hwy 12, take the first--almost immediate--exit (South E Street/Downtown). Go straight through the light at the bottom of the offramp, which puts you onto Bennett Valley Road. You will almost immediately pass, on your right, the fairgrounds racetrack and the fair marquee; take your next right onto Brookwood Ave. At the end of Brookwood, turn right onto Allen, which becomes Aston Ave. Just ahead on your right is a booth entrance for the fairgrounds. Enter and take the right side road. Head straight until you see the Lytle Cow Palace sign on the building. Turn left before the building and park in the marked parking areas.

**From the East via CA 12** From Highway 12, westbound, take the Downtown exit. Turn left at the stop light. This leads you to the entrance to the Sonoma County Fairgrounds. Follow the instructions above.

**RV INFORMATION -- BTCR**

**Reservations Required: Overnight Parking is permitted only by reservation. \$35 per night.**

Overnight parking will be available near the rings, not under cover. Electrical - 20A, 30A and 50A are available at sites throughout the Fairgrounds and this varies by site. Most sites offer water and some offer sewer. There is not a central dump station. Length of hose and electrical cable required is 10 feet to 50 feet so bring an extra-long hose and extra electrical cables. Bring levelers if you plan to park near the arena since the road is not level. Bring cones if you have a slide-out. Anyone planning to stay overnight at the trial site (RV, car, or truck) must complete the Reservation Form.

**DOGS ELIGIBLE TO ENTER**

This trial is open to all dogs of 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners Listing number, or approved Foundation Stock Service (FSS) breeds. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, nor will aggressive dogs, bitches in season, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

### INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
