**Notice to Exhibitors:**

All dogs must be on leash **at all times** except when competing.

Please make a copy of your entries so you know what you've entered before and after you arrive at the tests.

No refunds will be made for cancellations after the closing date or entries that are absent, disqualified, excused or barred from competition by decision of the Trial Committee.

Exhibitors are responsible for complete, accurate and **LEGIBLE** information on their entry forms. Be especially careful that your email address is clear.

Exhibitors are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children, and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.

Please be courteous and pick up after your dog.

All entries must be accompanied by entry fees to be valid. Returned checks do not constitute a valid entry. There will be a \$40 fee for any returned check. Please make checks payable to **BTCR** (Border Terrier Club of the Redwoods).

## BTCR RV Overnight Parking Information and Request:

- All overnight campers must confirm a space prior to the trial, even if power is not needed
- There are limited spaces with electrical hook-ups, our trial judges and volunteers are given priority
- RV spaces with electricity are \$25.00 per night. You may be assigned a shared power hook-up; the BTCR will provide a 30-amp splitter for your use
- All overnight spaces are pre-assigned, a volunteer will park you in your assigned spot
- Tow vehicle/trailers MAY be asked to unhitch to utilize all space. A parking spot in day use parking will be available for your tow vehicle
- **Weather** absolutely impacts how many RV's we can accommodate in the dry camping area (non-electrical). We will email you prior to the trial if we foresee an issue. During wet weather months a backup plan is strongly advised

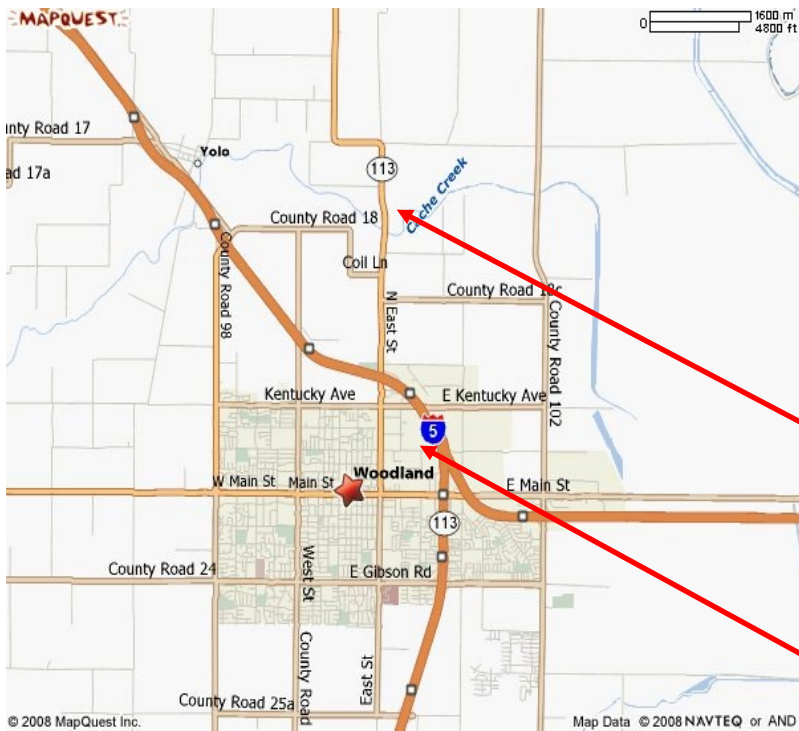
