These Earthdog Tests are held under the Rules and Procedures of the AMERICAN KENNEL CLUB are open to AKC Registered, ILP (PAL), or FSS recorded Dachshunds and the following Terrier Breeds: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Jagdterrier, Japanese, Lakeland, Manchester, Miniature Bull, Miniature Pinschers, Miniature Schnauzer, Norfolk, Norwich, Parson Russell, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Teddy Roosevelt, Welsh, West Highland White, Wire Fox, Yorkshire. Dogs must be at least six months old.

Running Order:

The running order for each class will be posted prior to the start of each class. The Judge will not wait for any late arriving dogs.

Dogs entered in the Master Earthdog class must check in with the Test Secretary no later than 7:15 AM for the SAT AM test, 12:30 PM for the SAT PM test and 7:15 AM for the SUN AM test and approximately ½ hour after last am class finishes for Sun pm. Only those dogs present will be deemed starters and will be entered in the random drawing for the Master Earthdog Class running.

Dogs must be at least 6 months of age. Spayed, neutered, limited registration, ILP, PAL dogs of eligible breeds are eligible to enter. **Bitches in season shall not be eligible to enter the tests.**

Photographs

The Border Terrier Club of the Redwoods will have volunteer photographers on site during the event. Candid pictures and posed pictures of awards will be taken to be used in the club newsletter and will be posted on the internet. Pictures may be forwarded to Border Terrier Club of America for utilization in the Borderline magazine. Presence on the site will be taken as indication of approval to be photographed.

- All overnight campers must confirm a space prior to the trial, if you don't have a confirmed space you may be turned away. This applies to ALL overnight campers
- Dry Camping spaces will be **limited to 10 RV's**
- There are limited spaces with electrical hook-ups, our trial judges and volunteers are given priority
- RV spaces with electricity are \$25.00 per night. You may be assigned a shared power hook-up; the BTCOR will provide a 30-amp splitter for your use
- All overnight spaces are pre-assigned, a volunteer will park you in your assigned spot
- Tow vehicle/trailers MAY be asked to unhitch to utilize all space. A parking spot in day use parking will be available for your tow vehicle

Weather absolutely impacts how many RV's we can safely accommodate. We will email you prior to the trial if we foresee an issue and have to cancel your parking spot


